- 4. Public registry record of FI name, address, license details, and responsible officers.
- 5. Public registry record of government or public body.
- 6. Exchange record of company's name, address, and directors.
- 7. At least one director's identity card, who approves the board resolution for account opening.
- 8. Certified by a department head/ manager of the client, who is independent to the persons whose identities are being verified (e.g. compliance, audit or human resources).
